

CHAPTER 4

CUSTOMER IDENTIFICATION CODES

4-1. GENERAL. DoD civilian and military personnel traveling on Military Airlift Command (MAC) aircraft must be identified with a Customer Identification Code (CIC) for ASIF billing purposes. All documents authorizing the Permanent Change of Station (PCS) and Temporary Duty (TDY) travel of civilians and TDY travel of military via ASIF shall include a CIC in addition to the accounting classification.

4-2. STRUCTURE AND COMPOSITION OF CIC. For transportation costs chargeable to Defense Agencies appropriations, the CIC consists of 15 characters constructed as follows:

<u>Position</u>	<u>Type Code</u>	<u>Purpose</u>
1	Numeric	Departmental Symbol. Code "1" is used by Office of the Secretary of Defense (OSD) and all Defense Agencies.
2	Alphanumeric	Identifies the activity to be charged. See section 4-3.
3	Alpha	Identifies the appropriation to be charged. See section 4-4 for applicable codes.
4	Alpha	Constant "Z"
5	Numeric	Identifies the fiscal year to be charged.
6-9	Alphanumeric	Can be used to identify travel order number or cargo shipment designator or ORC.
10-15	Alphanumeric	The accounting station number to be charged.
